IMPORTANT INFORMATION

- We offer an optional insurance scheme for our clients. The insurance fee is **€50**. In the event of an accident, the insurance coverage provides reimbursement of up to **€500**, subject to the applicable insurance terms and conditions.
- If the repair cost exceeds **€500**, the customer is responsible for an additional **30% of the amount exceeding €500**, subject to the applicable insurance terms.
- The motorcycle or tuk-tuk must be returned to the **same location where it was rented**, unless an alternative return location has been agreed in advance. Additional return charges may apply.

TERMS & CONDITIONS

1. The driver must have a **valid driving licence** authorising them to operate the rented motorcycle or tuk-tuk.
2. A **safety helmet must be worn at all times** when riding a motorcycle, including by the passenger/pillion rider.
3. If a police officer asks the driver to stop, the driver must stop safely and follow all lawful instructions.
4. Motorcycles and tuk-tuks are **not permitted on Sri Lankan expressways/highways where such vehicles are prohibited**.
5. **Payment for the agreed tuk-tuk rental period is strictly non-refundable, regardless of the reason for early return or cancellation.**
6. **IMPORTANT – MAJOR ACCIDENTS:** In the event of a major accident requiring repairs, the tuk-tuk may remain in the garage for the duration of the repair. The rental period will continue during this time, and the applicable rental charges will be deducted from the security deposit. Any additional repair or damage costs not covered by the insurance will be payable by the customer.
7. **IMPORTANT – LOSS OF VEHICLE DOCUMENTS:** If the customer loses, damages, or fails to return any vehicle documents, including the driving licence, insurance documents, registration documents, or other valuable vehicle papers provided with the tuk-tuk, the customer must pay the applicable document replacement and administrative charges.
8. The customer is responsible for returning the vehicle in the same condition in which it was received, subject to normal wear and tear.
